

News and Updates from National Office

Les Dickson, Representative to National Council

The article below is reprinted with permission from the August 2019 issue of the RASC Bulletin. It complements the talk that I am giving at the Saskatoon Centre meeting in November.

RASC Fundraising Forum

Questions at the General Assembly about RASC finances, budgets and what's considered charitable activity reflected incorrect interpretations of Canada Revenue Agency (CRA) rules and regulations. Last fall, an outline of RASC charitable practices was circulated by President Chris Gainor and Treasurer Catherine Carr to help clarify internal misunderstandings. It appears timely to share this information again, as well as an update on new developments. It's vital to our ability to financially sustain and strengthen operations that members support RASC's charitable initiatives.

Revenue Reporting

Membership, publication and charitable revenue are tracked separately in order to allocate fees to Centres and calculate income for reports. Having three revenue streams led to the belief that expenditure must be drawn from a related revenue source. That's not correct; there's no CRA or legal requirement to do so. It was also suggested that CRA changes in 2004 mandated a separation in membership, publication and donation revenue and expenditure. They did not. In fact, RASC minutes of a meeting with lawyer Susan Manwaring (engaged to ensure CRA compliance) made the opposite point. She advised there's no differentiating between "non-charitable money and charitable money – it doesn't matter where the money comes from." There are no CRA stipulations on how income is spent, other than revenue is allocated as per the charitable mandate.

Expense Reporting

Pro-rating operating costs to programs is an established charitable practice. RASC has not previously identified charitable programs in its financial statements. Instead, wages, occupancy costs, insurance etc. have been listed as lump sums. This can create the unfavourable impression of high administrative costs rather than worthy charitable program expenditure. In future, RASC will be assigning a portion of expenses to member services, Centre support-public outreach, national operations

and programs such as the robotic telescope, youth outreach, education etc. These are paper allocations of the estimated value of staff time, office expense and operating costs to program areas. Amounts will be assigned to activities in proportion to the resources expended in each area.

Membership Fees

RASC membership fees are not directly linked to the actual cost of member benefits, the face value of benefits provided or internal allocations of expenses such as staff and computer costs incurred serving members. Consequently, fee increases are simply the result of higher operating costs – everything from the price of paper, to rent increases and new program activities. 2018 membership fees represented 27.8% of total operating expenditure. The 2019 budgeted amount equals 28.3% of the total budget, a difference of less than half of one per cent. Initiatives to increase revenue from all sources are being diligently explored to help strengthen financial sustainability; 2018 publication revenue of 30% is projected at 33% of the total budget in 2019; donation and grant revenue increases from 24.7% to 33% of 2019 expenditure.

2019 Budget

At the GA, two significant donations were announced. One was a bequest pledge of \$1.5 million from Mr. Rudolph Dorner to establish the Dorner Telescope Museum. As this generous gift will be realized in the future, Mr. Dorner made an immediate donation of \$25,000. Carswell Family Foundation President Allan Carswell announced a first year contribution of \$100,000 for a 3 year funding commitment. \$75,000 in year two Trottier Family Foundation funding was also confirmed. Consequently, 2019 budget projections were revised to \$862,425 revenue, \$876,203 expenses, \$13,778 deficit. Regarding deficits, members referred to a difference in net results depending on cost allocations. Net proceeds are not affected by the program an expense is allocated to - the bottom line is the same regardless of assigning an expense to one area or another.

CRA T3010s

As a result of not previously recognizing charitable expenditure in its statements, RASC's annual T3010 financial report to CRA significantly understated charitable program expense at 11%. The advice of the auditor was to increase the amount in increments. Therefore, 2017 charitable programming was reported at 58% and 2018 was 69%. This assessment is moving towards a more typical allocation of between 70% and 85% in charitable programming expenditure.

Charitable Operations Summary

Revenue: There are stringent CRA rules for issuing charitable tax receipts and RASC complies with all requirements. Membership fees, publication and merchandise sales are earned revenue and because no tax receipt is issued for these revenues, income can be expended without restriction as per the charitable mandate.

Expenses: A charity's expenses must support its mandate and RASC expenditures fully comply. There are no CRA or legal requirements that restrict allocation of expenses as the charity wishes, other than that expenses comply with the mandate. Allocating pro-rated expenses to charitable program areas is a standard industry practice providing a donor friendly presentation of program costs. This paper allocation helps prevent a perception of high administrative expenses. RASC will be assigning a portion of operating costs to programs in future.

Net Proceeds: The difference between total revenue and expenses is not impacted by the allocation of expenses to one program or another. The bottom line would be the same.
